Conditions of Entry:

1. Each team must supply a non-playing badged umpire with their own whistle. **Please** supply umpires who are suitable to the standard they are umpiring. Teams must supply their own ball and bibs.
2. All players must be currently registered Netball Victoria Members.
3. Matches will be played according to Netball Victoria Rules.
4. Blood policy – as per Netball Victoria Rules.
5. No time allowed for injury. The committee will not be responsible for any injury, accidents, lost property occurring on the day.
6. Games will consist of 2 x 8 minute halves.
7. Players must play for one team only, except in case of injury when permission may/ may not be granted by the Committee.
8. In the case of a draw in finals, an extra two four minute ends will be played. If a draw results, then play will continue until one team has a two goal advantage.
9. 11 & under and 13 & Under teams may include two boys per team. If two (2) or more boys are on court at one time they must play in separate thirds of the court, ie one as GS or GA and one as C, WA or WD, or as GD or GK.
10. Late penalty – If a team is not present on the allocated court when starting siren is sounded, a penalty of 1 goal is incurred, after 1 minute 2 goals, then 2 goals per minute up to five minutes.

If a team is more than five minutes late, an immediate forfeit will be incurred on the offending team. The present team will be awarded the match with a score of 10 – 0. The umpire should note the time of the team's arrival and will consult with the Court Supervisor who will confirm the extent of the penalty against the offending team.
11. Nine trophies/medallions per team will be presented to the Winners and Runners-Up in all sections that play finals.
12. The tournament will be held irrespective of weather conditions.
13. No refunds will be issued after the closing date unless cancellation of section by Committee.
14. In the case of insufficient entries, the Committee reserve the right to regrade or cancel a section.
15. Entries may need to be limited – please get entries in early to avoid disappointment.
